#### 1 BASIS OF CONTRACT

- 1.1 The Order constitutes an offer by the Customer to purchase Goods and/or Services in accordance with these Conditions.
- 1.2 The Order shall only be deemed to be accepted when L Pickering and Sons Limited:
  - 1.2.1 issues written acceptance of the Order; or
  - 1.2.2 notifies the Customer that L Pickering and Sons Limited is able to provide the Goods and/or Services:
  - 1.2.3 begins to perform the Services; or
  - 1.2.4 commences performance of the Order for the Goods,

at which point and on which date the Contract shall come into existence (Commencement Date).

- 1.3 The Contract constitutes the entire agreement between the parties. The Customer acknowledges that it has not relied on any statement, promise or representation made or given by or on behalf of L Pickering and Sons Limited which is not set out in the Contract.
- 1.4 Any samples, drawings, descriptive matter or advertising issued by L Pickering and Sons Limited and any descriptions of the Goods or illustrations or descriptions of the Services contained in L Pickering and Sons Limited catalogues, website or brochures are issued or published for the sole purpose of giving an approximate idea of the Services and/or Goods described in them. They shall not form part of the Contract or have any contractual force.
- 1.5 These Conditions apply to the Contract to the exclusion of any other terms that the Customer seeks to impose or incorporate, or which are implied by trade, custom, practice or course of dealing.
- 1.6 Any quotation given by L Pickering and Sons Limited shall not constitute an offer and is only valid for a period of fourteen (14) Days from its date of issue.
- 1.7 The Customer shall ensure that the terms of its Order and any applicable Goods Specification or Service Specification are complete and accurate.
- 1.8 Any typographical, clerical or other error or omission in any sales literature, quotation, acceptance or offer, invoice or other documents or information issued by L Pickering and Sons Limited shall be subject to correction without liability on the part of L Pickering and Sons Limited.
- 1.9 The Customer shall indemnify L Pickering and Sons Limited against all liabilities, costs, expenses, damages and losses (including any direct, indirect or consequential losses, loss of profit, loss of reputation and all interest, penalties and legal costs (calculated on a full indemnity basis) and all other professional costs and expenses) suffered or incurred by L Pickering and Sons Limited arising out of or in connection with any claim made against L Pickering and Sons Limited for actual or alleged infringement of a third party's Intellectual Property Rights arising out of or in connection with L Pickering and Sons Limited's use of the Goods Specification. This clause 1.9 shall survive termination of the Contract.
- L Pickering and Sons Limited reserves the right to make any changes to the Goods Specification or Services Specification (i) which are required to conform with any applicable statutory requirements or other regulations or (ii) where the Goods or Services are supplied to the Customer's specification which do not materially affect their quality or performance taking into account industry standard tolerances applicable to such Services including the weight, thickness, grade and length of the Deliverables and/ or (iii) to align with the capability of L Pickering and Sons Limited's manufacturing facility. In the case of (iii) upon receipt of L Pickering and Sons Limited's requested changes, the Customer may require L Pickering and Sons Limited to delay manufacturing until the Customer has given written approval of the changes in writing. Absent written approval within 2 working days, L Pickering and Sons Limited may commence the manufacture of the Goods the subject of the Order .L Pickering and Sons Limited reserve the right to charge for any amendments.
- 1.11 No Order which has been accepted by L Pickering and Sons Limited may be cancelled by the Customer except with the agreement in writing of L Pickering and Sons Limited and on the terms that the Customer shall indemnify L Pickering and Sons Limited in full against all loss (including without prejudice to the generality of the foregoing) loss of profit, costs (including the cost of all labour and materials used and pre-ordered), damages, charges and expenses incurred by L Pickering and Sons Limited as a result of the cancellation.
- 1.12 All of these Conditions shall apply to the supply of both Goods and Services except where application to one or the other is specified.

# 2 GOODS

2.1 The Goods are described in the quotation and the Goods Specification. The quotation shall contain the validity period of the quotation, as well as the quantity, price and delivery date for the Goods.

2.2 The Customer waives any right it might otherwise have to rely on any term endorsed upon, delivered with or contained in any documents of the Customer that is inconsistent with these Conditions.

#### 3 DELIVERY OF GOODS

- 3.1 L Pickering and Sons Limited shall ensure that each Delivery of the Goods is accompanied by a delivery note which shows the date of the Order, the type and quantity of the Goods and the Customer and Supplier's reference numbers.
- 3.2 L Pickering and Sons Limited shall, or shall procure, Delivery of the Goods to the location set out in the Order or such other location as the parties may agree (Delivery Location) at a time as agreed between the parties.
- 3.3 Delivery is completed when Goods are placed at the Customer's disposal at the Delivery Location.
- Any dates quoted for Delivery of the Goods are approximate only, and the time of Delivery is not of the essence. If L Pickering and Sons Limited fails to deliver, or procure Delivery of the Goods, its liability shall be limited to the costs and expenses incurred by the Customer in obtaining replacement goods of similar description and quality in the cheapest market available, less the price of the Goods. L Pickering and Sons Limited shall not be liable for any delay in Delivery of the Goods that is caused by a Force Majeure Event.
- 3.5 L Pickering and Sons Limited shall inform the Customer in writing not less than 2 days before the Delivery Date that the Goods are ready for collection. If the Customer fails to collect or take Delivery of the Goods within one (1) Business Day of the Delivery Date, then except where such failure or delay is caused by a Force Majeure Event or by L Pickering and Sons Limited failure to comply with its obligations under the Contract in respect of the Goods:
  - 3.5.1 delivery of the Goods shall be deemed to have been completed at 09.00hr on the first Business Day following the Delivery Date; and
  - 3.5.2 L Pickering and Sons Limited shall store the Goods until delivery takes place, and may, at its sole discretion, charge the Customer for all related costs and expenses (including insurance).
- 3.6 If thirty (30) days after L Pickering and Sons Limited notified the Customer that the Goods were ready for Delivery the Customer has not collected or taken delivery of them, L Pickering and Sons Limited may, at its sole option, resell or otherwise dispose of part or all of the Goods and, after deducting reasonable storage and selling costs, account to the Customer for any excess over the price of the Goods or charge the Customer for any shortfall below the price of the Goods.
- 3.7 Notwithstanding that the Customer is responsible for any risk in the Goods during transit from the Delivery Location, no claim for any Goods damaged in transit will be considered by L Pickering and Sons Limited unless:
  - 3.7.1 the delivery note relating to such Goods is clearly marked with the words "Goods received damaged" or words of a similar nature and such statement on the delivery note is signed by the Customer; and
  - 3.7.2 L Pickering and Sons Limited is advised in writing of the details of the damage, which is accompanied by a copy of the signed delivery note in accordance with clause 3.7.1 within five (5) Business Days of the Customer's receipt of the Goods.
- The Customer shall not be entitled to reject the Goods if L Pickering and Sons Limited deliver up to and including 10 per cent more or less than the quantity of Goods ordered.
- 3.9 L Pickering and Sons Limited may deliver the Goods by instalments, which shall be invoiced and paid for separately. Each instalment shall constitute a separate contract. Any delay in delivery or defect in an instalment shall not entitle the Customer to cancel any other instalment.

## 4 TITLE AND RISK

- 4.1 The risk in the Goods shall pass to the Customer on completion of delivery.
- 4.2 Without prejudice to clause 3.6, no title in any goods covered by the Contract shall pass to the Customer until L Pickering and Sons Limited has received payment in full and in cleared funds for:
  - 4.2.1 the Goods; and
  - 4.2.2 any other goods or services that L Pickering and Sons Limited has supplied to the Customer or Customer Group under this or any other agreement,

in which case title to the Goods shall pass at the time of receipt of payment of all such sums.

- 4.3 Without prejudice to clause 3.6, until title to the Goods has passed to the Customer, the Customer shall:
  - 4.3.1 hold the Goods on a fiduciary basis as L Pickering and Sons Limited bailee;
  - 4.3.2 store the Goods separately from all other goods held by the Customer so that they remain readily identifiable as L Pickering and Sons Limited property;
  - 4.3.3 not remove, deface or obscure any identifying mark or packaging on or relating to the Goods;
  - 4.3.4 maintain the Goods in satisfactory condition and keep them insured against all risks for their full price on L Pickering and Sons Limited behalf from the date of delivery;
  - 4.3.5 notify L Pickering and Sons Limited immediately if it becomes subject to any of the events listed in clause 14.1.2 to clause 14.1.13; and
  - 4.3.6 give L Pickering and Sons Limited such information relating to the Goods as L Pickering and Sons Limited may require from time to time but the Customer may resell or use the Goods in the ordinary course of its business.

# L Pickering and Sons Limited

# **Terms and Conditions**

- 4.4 Subject to clause 4.7, the Customer may resell or use the Goods in the ordinary course of its business (but not otherwise) before L Pickering and Sons Limited receives payment for the Goods. However, if the Customer resells the Goods before that time:
  - 4.4.1 It does so as principal and not as L Pickering and Sons Limited's agent; and
  - 4.4.2 title to the Goods shall pass from L Pickering and Sons Limited to the Customer immediately before the time at which resale by the Customer occurs.
- 4.5 If before title to the Goods passes to the Customer the Customer becomes subject to any of the events listed in clause 14.1.2 to clause 14.1.13, or L Pickering and Sons Limited reasonably believes that any such event is about to happen and notifies the Customer accordingly, then, provided the Goods have not been resold, or irrevocably incorporated into another product, and without limiting any other right or remedy L Pickering and Sons Limited may have, L Pickering and Sons Limited may at any time require the Customer to deliver up the Goods and, if the Customer fails to do so promptly, enter any premises of the Customer or of any third party where the Goods are stored in order to recover them.
- 4.6 Where the Services include the warehousing of the Customer's Goods, the following provisions shall apply:
  - 4.6.1 unless agreed expressly in writing the Customer's Goods shall be stored at the Customer's risk;
  - 4.6.2 title to the Customer's Goods shall remain with the Customer at all times.

#### 5 'NON-PRIME' GOODS

Goods sold as 'non-prime' or which L Pickering and Sons Limited and the Customer agree to be 'non-prime' are sold, without warranty and with all defects whether or not inspected by the Customer prior to delivery. Any statement, specification, description or other information provided by L Pickering and Sons Limited in respect of such goods is given in good faith, but L Pickering and Sons Limited accepts no responsibility for its accuracy. Under no circumstances will L Pickering and Sons Limited be under any obligation to replace or make good such Goods, or be liable for any claim whatsoever in respect of them.

#### 6 SUPPLY OF SERVICES

- 6.1 L Pickering and Sons Limited shall provide the Services to the Customer in accordance with the Service Specification in all material respects.
- 6.2 L Pickering and Sons Limited shall use all reasonable endeavours to meet any performance dates for the Services specified in the quotation, but any such dates shall be estimates only and time shall not be of the essence for the performance of the Services.
- 6.3 L Pickering and Sons Limited reserves the right to amend the Service Specification if necessary to comply with any applicable law or regulatory requirement, or if the amendment will not materially affect the nature or quality of the Services, and L Pickering and Sons Limited shall notify the Customer in any such event.
- 6.4 L Pickering and Sons Limited warrant to the Customer that the Services will be provided using reasonable care and skill

## 7 TOOLING

- 7.1 Where the Customer has provided Tooling to L Pickering and Sons Limited for the provision of the Services unless otherwise agreed in writing:
  - 7.1.1 title to the Tooling shall remain with the Customer at all times;
  - 7.1.2 risk in the Tooling shall remain with the Customer and the Customer shall be responsible for insuring the Tooling against loss, theft, damage and destruction whilst at L Pickering and Sons Limited premises;
  - 7.1.3 L Pickering and Sons Limited shall return the Tooling to the Customer, on the Customer's written request and at the Customer's cost;
  - 7.1.4 L Pickering and Sons Limited shall not be liable for the completion of any Orders requiring the Tooling where such Tooling has been returned to the Customer at the Customer's request, damaged or destroyed by the Customer or damaged or destroyed due to an inherent defect in the Tooling.

# 8 CUSTOMER'S OBLIGATIONS

- 8.1 The Customershall:
  - 8.1.1 ensure that the terms of the Order and (if submitted by the Customer) the Goods Specification and the Services Specification are complete and accurate;
  - 8.1.2 co-operate with L Pickering and Sons Limited in all matters relating to the Goods and Services;
  - 8.1.3 provide L Pickering and Sons Limited with such information, forward delivery dates, locations and materials as L Pickering and Sons Limited may reasonably require to supply the Goods and Services, and ensure that such information is accurate in all material respects;
  - 8.1.4 obtain and maintain all necessary licenses, permissions and consents which may be required for the provision of Goods and Services before the date on which the Goods are to be supplied or the Services are to start;
  - 8.1.5 deliver to L Pickering and Sons Limited at the Customer's cost, any Tooling required by L

Pickering and Sons Limited to fulfil the Order as agreed by L Pickering and Sons Limited in writing.

- 8.2 If L Pickering and Sons Limited's performance of any of its obligations under the Contract is prevented or delayed by any act or omission by the Customer or failure by the Customer to perform any relevant obligation (Customer Default):
  - 8.2.1 without limiting or affecting any other right or remedy available to it, L Pickering and Sons Limited shall have the right to suspend performance of the Services until the Customer remedies the Customer Default, and to rely on the Customer Default to relieve it from the performance of any of its obligations in each case to the extent the Customer Default prevents or delays L Pickering and Sons Limited's performance of any of its obligations;
  - 8.2.2 L Pickering and Sons Limited shall not be liable for any costs or losses sustained or incurred by the Customer arising directly or indirectly from L Pickering and Sons Limited's failure or delay to perform any of its obligations as set out in this clause 8.2; and
  - 8.2.3 the Customer shall reimburse L Pickering and Sons Limited on written demand for any costs or losses sustained or incurred by L Pickering and Sons Limited arising directly or indirectly from the Customer Default.

#### 9 QUALITY

- 9.1 Where L Pickering and Sons Limited is not the manufacturer of the Goods, L Pickering and Sons Limited shall endeavour to transfer to the Customer the benefit of any warranty or guarantee given to L Pickering and Sons Limited.
- 9.2 L Pickering and Sons Limited warrants that on delivery the Goods and/or provision of Services, as applicable, shall:
  - 9.2.1 conform in all material respects with their description and any applicable Goods Specification and Service Specification; and
  - 9.2.2 be free from material defects in design and workmanship.
- 9.3 Subject to clause 9.4, if:
  - 9.3.1 the Customer gives notice in writing within a reasonable time of discovery that some or all of the Goods and/or Services do not comply with the warranty set out in clause 9.2;
  - 9.3.2 L Pickering and Sons Limited is given a reasonable opportunity of examining such Goods; and
  - 9.3.3 the Customer (if asked to do so by L Pickering and Sons Limited) returns such Goods to L Pickering and Sons Limited place of business at L Pickering and Sons Limited cost.

L Pickering and Sons Limited shall, at its option, repair or replace the defective Goods and/or provide replacement Services, or refund the price or issue a credit note for the defective Goods or Services in full, less any scrap value if Goods are retained at any Customer location.

- 9.4 L Pickering and Sons Limited shall not be liable for the Goods' and/or Services failure to comply with the warranty in clause 9.1 or 9.2 if:
  - 9.4.1 the Customer makes any further use of such Goods and/or Services after giving a notice in accordance with clause 9.3;
  - 9.4.2 the defect arises because the Customer failed to follow L Pickering and Sons oral or written instructions as to the storage, installation, commissioning, use or maintenance of the Goods and/or Services or (if there are none) good trade practice;
  - 9.4.3 the defect arises as a result of L Pickering and Sons Limited following any drawing, design or Goods Specification or Service Specification supplied by the Customer;
  - 9.4.4 the Customer alters or repairs such Goods without the written consent of L Pickering and Sons Limited;
  - 9.4.5 the defect arises as a result of fair wear and tear, wilful damage, negligence, or abnormal working conditions;
  - 9.4.6 the Goods and or Services differ from the Goods Specification and/or Service Specification as a result of changes made to ensure they comply with applicable statutory or regulatory standards;
  - 9.4.7 the Customer has not paid for the Goods and/or Services;
  - 9.4.8 the defect arises as a result of incomplete, inaccurate or defective information or instructions provided by the Customer; or
  - 9.4.9 the Goods are sold as 'non-prime' goods in accordance with clause 5.
- 9.5 Except as provided in this clause 8.2, L Pickering and Sons Limited shall have no liability to the Customer in respect of the Goods' or Services' failure to comply with the warranty set out in clause 9.1 or 9.2.
- 9.6 These Conditions shall apply to any repaired or replacement Goods and/or Services supplied by L Pickering and Sons Limited under clause 9.3.

#### 10 CHARGES AND PAYMENT

- 10.1 The price for Goods and Services shall be the price set out in the Order.
- 10.2 L Pickering and Sons Limited reserves the right to:
  - 10.2.1 increase the price of the Goods or Services, by giving notice to the Customer at any time before delivery, to reflect any increase in the cost to L Pickering and Sons Limited that is due to:
    - (a) any factor beyond the control of L Pickering and Sons Limited (including foreign exchange fluctuations, increases in taxes and duties, and increases in labour, materials and other manufacturing costs);
    - (b) any request by the Customer to change the delivery date(s), quantities or types of Goods ordered, the Goods Specification or the Service Specification; and/or
    - (c) any delay caused by any instructions of the Customer in respect of the Goods, the Services or failure of the Customer to give L Pickering and Sons Limited adequate or accurate information or instructions in respect of the Goods or Services.
- 10.3 In respect of Goods and Services, L Pickering and Sons Limited shall invoice the Customer on or at any time after Delivery of the Goods or completion of the Services.
- 10.4 The Customer shall pay each invoice submitted by L Pickering and Sons Limited:
  - 10.4.1 on or before the last day of the month following the month in which the invoice was dated (**Due Date**); and
  - 10.4.2 in full and in cleared funds to a bank account nominated in writing by L Pickering and Sons Limited, and time for payment shall be of the essence of the Contract.
- All amounts payable by the Customer under the Contract are exclusive of amounts in respect of value added tax chargeable from time to time (VAT). Where any taxable supply for VAT purposes is made under the Contract by L Pickering and Sons Limited to the Customer, the Customer shall, on receipt of a valid VAT invoice from L Pickering and Sons Limited, pay to L Pickering and Sons Limited such additional amounts in respect of VAT as are chargeable on the supply of the Services or Goods at the same time as payment is due for the supply of the Services or Goods.
- Without limiting any other right or remedy of L Pickering and Sons Limited, if the Customer fails to make any payment due to L Pickering and Sons Limited under the Contract by the Due Date, L Pickering and Sons Limited shall have the right to charge interest on the overdue amount at the rate of 4 per cent per annum above the then current Bank of England's base rate accruing on a daily basis from the Due Date until the date of actual payment of the overdue amount, whether before or after judgment, and compounding quarterly. If the Bank of England's base rate is 0% or below, interest will accrue at 4%.
- 10.7 The Customer shall pay all amounts due under the Contract in full without any deduction or withholding except as required by law and the Customer shall not be entitled to assert any credit, set-off or counterclaim against L Pickering and Sons Limited in order to justify withholding payment of any such amount in whole or in part. L Pickering and Sons Limited may, without limiting its other rights or remedies, set off any amount owing to it by the Customer against any amount payable by L Pickering and Sons Limited to the Customer under this Contract and any other contract between the parties.
- 10.8 L Pickering and Sons Limited will have, in addition to any other right or remedy available to it, a lien and power of sale over the Tooling or Customer owned Goods for any outstanding payments in connection with this Contract, or any other agreement between the parties. If any such sums remain unpaid (in full or in part) more than three (3) months after such payment becomes due, L Pickering and Sons Limited, shall be entitled to:
  - 10.8.1 retain the Tooling or Customer owned Goods in its possession until payment in full is made; or
  - 10.8.2 dispose of the Tooling or Customer owned Goods in such manner and at such price as it sees fit on the expiry of twenty-one (21) days' notice to the Customer in writing.
- 10.9 L Pickering and Sons Limited will apply the proceeds of any disposal under clause 10.8 in the following order:
  - 10.9.1 payment of the price for an outstanding goods and/or services falling due under this Contract;
  - 10.9.2 payment of any remainder to the Customer.

## 11 INTELLECTUAL PROPERTYRIGHTS

- 11.1 All Intellectual Property Rights in or arising out of or in connection with the Goods and Services shall be owned by L Pickering and Sons Limited.
- 11.2 To the extent that L Pickering and Sons Limited advises or assists in the creation of the Tooling, all Intellectual Property Rights in or arising out of or in connection with such Tooling shall be owned jointly by the Customer and L Pickering and Sons Limited.
- 11.3 The Customer acknowledges that, in respect of any third party Intellectual Property Rights in the Services, the Customer's use of any such Intellectual Property Rights is conditional on L Pickering and Sons Limited obtaining a written license from the relevant licensor on such terms as will entitle L Pickering and Sons Limited to license such rights to the Customer.

## 12 CONFIDENTIALITY

A party (Receiving Party) shall keep in strict confidence all technical or commercial know-how, specifications, inventions, processes or initiatives which are of a confidential nature and have been disclosed to the Receiving Party by the other party (Disclosing Party), its employees, agents or subcontractors, and any other confidential information concerning the Disclosing Party's business or its products or its services which the Receiving Party may obtain. The Receiving Party shall restrict disclosure of such confidential information to such of its employees, agents or subcontractors as need to know it for the purpose of discharging the Receiving Party's obligations under the Contract, and shall ensure that such employees, agents or subcontractors are subject to obligations of confidentiality corresponding to those which bind the Receiving Party. This clause 13 shall survive termination of the Contract.

#### 13 LIMITATION OF LIABILITY: THE CUSTOMER'S ATTENTION IS PARTICULARLY DRAWN TO THIS CLAUSE

- 13.1 Nothing in these Conditions shall limit or exclude L Pickering and Sons Limited liability for:
  - 13.1.1 death or personal injury caused by its negligence, or the negligence of its employees, agents or subcontractors;
  - 13.1.2 fraud or fraudulent misrepresentation;
  - 13.1.3 breach of the terms implied by section 2 of the Supply of Goods and Services Act 1982 (title and quiet possession);
  - 13.1.4 breach of the terms implied by section 12 of the Sale of Goods Act 1979 (title and quiet possession); or
  - 13.1.5 defective products under the Consumer Protection Act 1987.
- 13.2 Subject to clause 13.1:
  - 13.2.1 L Pickering and Sons Limited shall under no circumstances whatever be liable to the Customer, whether in contract, tort (including negligence), breach of statutory duty, or otherwise, for:
    - (a) any loss arising from or in connection with loss of revenues, profits, contracts or business or failure to realise anticipated savings; or
    - (b) any indirect or consequential loss arising under or in connection with the Contract.
  - 13.2.2 L Pickering and Sons Limited total liability to the Customer in respect of all other losses arising under or in connection with the Contract, whether in contract, tort (including negligence), breach of statutory duty, or otherwise, shall in no circumstances exceed the amount paid for the Goods and/or Services.
- 13.3 For the avoidance of doubt, L Pickering and Sons Limited shall not be liable to the Customer for any defects in the material of the Goods or Deliverables caused by their manufacture or material make-up.
- Except as set out in these Conditions, all warranties, conditions and other terms implied by statute or common law are, to the fullest extent permitted by law, excluded from the Contract.
- 13.5 This clause 13 shall survive termination of the Contract.

## 14 TERMINATION

- 14.1 Without limiting its other rights and remedies, each party may terminate the Contract with immediate effect by giving written notice (excluding by fax or email) to the other party if:
  - 14.1.1 the other party commits a material breach of its obligations under this Contract and (if such breach is remediable) fails to remedy that breach within 30 days after receipt of notice in writing of the breach:
  - the other party suspends, or threatens to suspend, payment of its debts or is unable to pay its debts as they fall due or admits inability to pay its debts or (being a company) is deemed unable to pay its debts within the meaning of section 123 of the Insolvency Act 1986 or (being an individual) is deemed either unable to pay its debts or as having no reasonable prospect of so doing, in either case, within the meaning of section 268 of the Insolvency Act 1986 or (being a partnership) has any partner to whom any of the foregoing apply;
  - the other party commences negotiations with all or any class of its creditors with a view to rescheduling any of its debts, or makes a proposal for or enters into any compromise or arrangement with its creditors other than (where a company) for the sole purpose of a scheme for a solvent amalgamation of that other party with one or more other companies or the solvent reconstruction of that other party;
  - a petition is filed, a notice is given, a resolution is passed, or an order is made, for or in connection with the winding up of the other party (being a company) other than for the sole purpose of a scheme for a solvent amalgamation of the other party with one or more other companies or the solvent reconstruction of that other party;
  - 14.1.5 the other party (being an individual) is the subject of a bankruptcy petition or order;
  - 14.1.6 a creditor or encumbrance of the other party attaches or takes possession of, or a distress, execution, sequestration or other such process is levied or enforced on or sued against, the whole or any part of its assets and such attachment or process is not discharged within 14 days;
- 14.1.7 an application is made to court, or an order is made, for the appointment of an administrator or if L Pickering and Sons Ltd Terms and Conditions

# L Pickering and Sons Limited

### **Terms and Conditions**

a notice of intention to appoint an administrator is given or if an administrator is appointed over the other party (being a company);

- 14.1.8 a floating charge holder over the assets of the other party (being a company) has become entitled to appoint or has appointed an administrative receiver;
- 14.1.9 a person becomes entitled to appoint a receiver over the assets of the other party or a receiver is appointed over the assets of the other party;

- 14.1.11 any event occurs, or proceeding is taken, with respect to the other party in any jurisdiction to which it is subject that has an effect equivalent or similar to any of the events mentioned in clause 14.1.2 to clause 14.1.9 (inclusive);
- 14.1.12 the other party suspends, threatens to suspend, ceases or threatens to cease to carry on, all or substantially the whole of its business; or
- the other party (being an individual) dies or, by reason of illness or incapacity (whether mental or physical), is incapable of managing his own affairs or becomes a patient under any mental health legislation.
- 14.2 Without limiting its other rights and remedies, L Pickering and Sons Limited shall have the right to suspend the supply of Services and all further deliveries of Goods under the Contract or any other contract between the Customer and L Pickering and Sons Limited if:
  - 14.2.1 the Customer fails to pay any amount due under this Contract on the due date for payment; or
  - 14.2.2 the Customer becomes subject to any of the events listed in clause 14.1.2 to clause 14.1.13, or L Pickering and Sons Limited reasonably believes that the Customer is about to become subject to any of them; or
  - 14.2.3 L Pickering and Sons Limited performance of its obligations under the Contract is prevented or delayed by a Customer Default, until such a time as the Customer remedies the Customer Default.
- 14.3 L Pickering and Sons Limited shall not be liable for any costs or losses sustained or incurred by the Customer arising directly or indirectly from L Pickering and Sons Limited failure or delay to perform any of its obligations as a result of a Customer Default and the Customer shall reimburse L Pickering and Sons Limited on written demand for any costs or losses sustained or incurred by L Pickering and Sons Limited arising directly or indirectly from the Customer Default.

#### 15 CONSEQUENCES OF TERMINATION

- 15.1 On termination of the Contract for any reason:
  - 15.1.1 the Customer shall immediately pay to L Pickering and Sons Limited all of L Pickering and Sons Limited outstanding unpaid invoices and interest and, in respect of Services supplied but for which no invoice has yet been submitted, L Pickering and Sons Limited shall submit an invoice, which shall be payable by the Customer immediately on receipt;
  - the Customer shall return all of L Pickering and Sons Limited Good and any Deliverables which have not been fully paid for. If the Customer fails to do so, then L Pickering and Sons Limited may enter the Customer's premises and take possession of them. Until they have been returned, the Customer shall be solely responsible for their safe keeping and will not sue them for any purpose;
  - 15.1.3 the accrued rights and remedies of the parties as at termination shall not be affected, including the right to claim damages in respect of any breach of the Contract which exited at or before the date of termination or expiry; and
  - 15.1.4 clauses which expressly or by implication have effect after termination shall continue in dull force and effect.

## 16 GENERAL

- 16.1 Force majeure:
  - 16.1.1 For the purposes of this contract, Force Majeure Event means an event beyond the reasonable control of L Pickering and Sons Limited or its sub-contractors including but not limited to strikes, lock-outs or other industrial disputes (whether involving the workforce of the party or any other party), failure of a utility service or transport network, act of God, war, riot, civil commotion, malicious damage, compliance with any law or governmental order, rule, regulation or direction, accident, breakdown of plant or machinery, fire, flood, storm or default of suppliers or subcontractors.
  - 16.1.2 L Pickering and Sons Limited shall not be liable to the Customer as s result of any delay or failure to perform its obligations under this Contract as a result of a Force Majeure Event.
  - 16.1.3 If the Force Majeure Event prevents L Pickering and Sons Limited from providing any of the Services and/or goods for more than 24 weeks, L Pickering and Sons Limited shall, without limiting its other rights or remedies, have the right to terminate this Contract immediately by giving written notice to the Customer.

## 16.2 Assignment and subcontracting:

- 16.2.1 L Pickering and Sons Limited may at any time assign, transfer, charge, subcontract or deal in any other manner with all or any of its rights under the Contract and may subcontract or delegate in any manner any or all of its obligations under the Contract to any third party.
- 16.2.2 The Customer shall not, without the prior written consent of L Pickering and Sons Limited, assign, transfer, charge, subcontract or deal in any other manner with all or any of its rights or obligations under the Contract.

#### 16.3 Notices:

- 16.3.1 Any notice or other communication required to be given to a party under or in connection with this Contract shall be in writing and shall be delivered to the other party personally or sent by prepaid first- class post, recorded delivery or by commercial courier, at its registered office (if a company) or (in any other case) its principal place of business, or sent by fax to the other party's main fax number.
- Any notice or other communication shall be deemed to have been duly received if delivered personally, when left at such address or, if sent by prepaid first-class post or recorded delivery, at 9.00 am on the second Business Day after posting, or if delivered by commercial courier, on the date and at the time that the courier's delivery receipt is signed, or if sent by fax, on the next Business Day after transmission.

## 16.4 Waiver and cumulative remedies:

- 16.4.1 A waiver by L Pickering and Sons Limited of any right under the Contract is only effective if it is in writing and shall not be deemed to be a waiver of any subsequent breach or default. No failure or delay by L Pickering and Sons Limited in exercising any right or remedy under the Contract or by law shall constitute a waiver of that or any other right or remedy, nor preclude or restrict its further exercise. No single or partial exercise of such right or remedy shall preclude or restrict the further exercise of that or any other right or remedy.
- 16.4.2 Unless specifically provided otherwise, rights arising under the Contract are cumulative and do not exclude rights provided by law.

## 16.5 Severance:

- 16.5.1 If a court or any other competent authority finds that any provision of the Contract (or part of any provision) is invalid, illegal or unenforceable, that provision or part-provision shall, to the extent required, be deemed deleted, and the validity and enforceability of the other provisions of the Contract shall not be affected.
- 16.5.2 If any invalid, unenforceable or illegal provision of the Contract would be valid, enforceable and legal if some part of it were deleted, the provision shall apply with the minimum modification necessary to make it legal, valid and enforceable.
- 16.6 No partnership: Nothing in the Contract is intended to, or shall be deemed to, constitute a partnership or joint venture of any kind between any of the parties, nor constitute any party the agent of another party for any purpose. No party shall have authority to act as agent for, or to bind, the other party in any way.
- 16.7 Third parties: A person who is not a party to the Contract shall not have any rights under or in connection with it.
- 16.8 Variation: Except as set out in these Conditions, any variation, including the introduction of any additional terms and conditions, to the Contract shall only be binding when agreed in writing and signed by L Pickering and Sons Limited.
- Governing law and jurisdiction: This Contract, and any dispute or claim arising out of or in connection with it or its subject matter or formation (including non-contractual disputes or claims), shall be governed by, and construed in accordance with, English law, and the parties irrevocably submit to the non-exclusive jurisdiction of the courts of England and Wales.
